CONDUCT STANDARDS: Kanakuk desires for everybody who comes to Kamp to see Jesus by the way our staff and volunteers are unified in love for God and love for each other. Kanakuk expects high standards of moral and ethical treatment of campers, staff, and volunteers in its care. Integrity, loyalty, honesty, and faithfulness are pillars of Kanakuk. As an expression of our union with Christ and other believers, Kanakuk expects all staff and volunteers to whole-heartedly commit to living in a manner worthy of the Gospel.

Kanakuk does not allow staff or volunteers to personally use controlled substances (including marijuana), alcohol, or tobacco. Such substances are not allowed on or during any of the organization's properties or activities, and the use of which is not to be promoted contrary to the organization's belief.

Kanakuk staff and volunteers are committed to sexual purity and will abstain from all forms of sexual activity outside of marriage as defined by Scripture. This includes any sexual activity related to fornication, pornography, homosexuality, bisexuality, bestiality, and/or adultery. All staff and volunteers are expected to live in accordance with Kanakuk's belief on human sexuality and marriage.

Kanakuk has a "zero tolerance" policy for any form of sexual, physical, verbal, or emotional abuse. Any staff member or volunteer found in violation of this policy will be terminated immediately and reported to proper authorities. Kanakuk mandatorily reports all suspicions of abuse and cooperates with local authorities to prosecute and convict child abusers.

Kanakuk expects all staff and volunteers to strictly adhere to these standards and immediately report any deviation of Kamp's beliefs, standards, and/or practices to Kamp leadership.

APPEARANCE STANDARDS: In an effort to avoid confusion with our purpose and ministry, Kanakuk staff and volunteers are committed to a clean-cut, well-groomed appearance at Kamp. Kanakuk does NOT allow the following while volunteering at Kamp: Shaved Heads, Punk or Wild Hairstyles, Long Hair on Guys (Not Below Ears), Beards, Mustaches, Facial Hair, Visible Tattoos (Must Be Covered), Body Piercings (Girls Stud Earrings Okay), Two Piece Swimsuits.

I have read and agree to support, uphold, and live in accordance with the beliefs, standards, and practices listed above. I understand that any deviation from these beliefs, standards, and practices could result in my dismissal from Kamp. VOLUNTEER RELEASE, TERMS, & CONDITIONS

Kanakuk Ministries is a 501(c)(3) not-for-profit organization located at 1353 Lake Shore Drive, Branson Missouri 65616, hereafter ("Kanakuk").

In exchange for my child being allowed to participate in the Kanakuk Volunteer Program (the "Program"), we, the parent(s) or legal guardian(s) (individually and collectively referred to below in the first person singular) of the child identified on this Application Form agree to be bound by each of the following:

VOLUNTEER CONDITIONS

1. I understand that my child is a volunteer worker and not an employee of Kanakuk. My child will not receive any form of salary, commission, employment benefits, or personal time off.
2. I agree to provide health insurance coverage for my child for any accidents or illnesses that occur while volunteering at Kanakuk.
3. I accept financial responsibility for all medical expenses incurred for any illnesses or injury sustained by my child while volunteering at Kanakuk.
4. I will reimburse Kanakuk Kamps should they incur any expense for an illness/injury on my child's behalf, or to file any necessary claim forms for payment or reimbursement from my individual medical insurance carrier.
5. Enrollment will not be complete until we receive the applicant's Health History & Emergency Information, which can be filled out online.
6. In the event of an emergency, I hereby give my permission to the physician selected by the camp medical staff, Kamp Director, or their designee(s) to provide medical treatment including, but not limited to, transport, hospitalize, secure proper treatment, and to order injections and/or anesthesia and/or surgery for the family member as named herein.

OTHER CONDITIONS

1. Minors volunteering at camp without their parents/legal guardians will not be allowed to make outgoing phone calls. To protect attendee morale, no incoming calls are allowed. Emergencies will be carefully handled by the camp director.
2. Minors volunteering at camp without their parents/legal guardians are not allowed to have or use cell phones, mp3 players or other electronic devices at Kanakuk except that digital cameras are acceptable.
3. Kanakuk is not responsible for the loss or damage of personal items.
4. Kanakuk reserves the right to dismiss any individual whose behavior, in our opinion, is detrimental to themselves or other guests.

PARENT RELEASE

1. I understand and confirm that our child's participation in the Program is voluntary.
 2. I understand that all camping and recreational programs carry with them significant risks. Although Kanakuk has taken reasonable and prudent steps to reduce foreseeable risks, they still exist.
 3. I assume all risks, known and unknown, foreseeable and unforeseeable, in any way connected with my child's participation in the Program. I accept personal responsibility for any liability, injury, loss, or damage to persons or property in any way connected with my child's participation in the Program.
 4. I agree to release, hold harmless and indemnify Kanakuk, its directors, officers, employees, agents, volunteers, successors, and assigns from any and all liability for claims for injury, loss, or damage to persons or property including Kanakuk's actions, omissions or negligence in any way connected with my child's participation in the Program (the "Released Claims."). I agree to indemnify and reimburse Kanakuk for its' attorney fees incurred in defending the Released Claims.
 5. I understand that photographs and video footage taken of my child as a result of participation in the Program may be used in Kanakuk materials, publications and/or posted to the internet. By signature below, I waive any right that I or my child may have to inspect or to approve the materials that Kanakuk may choose to publish.
 6. I recognize the religious nature of Kanakuk and agree that Kanakuk has the right to dismiss my child for any conduct that stands in contradiction to Kanakuk's stated beliefs, policies, and mission. I understand that such conduct would impede and burden the integrity and religious mission of Kanakuk as well as interfere with the religious experience of other campers and staff. I submit to the designated authority of Kanakuk to resolve any disputes relating to Kamper policies and practices. I understand that, should my child be dismissed, no tuition refund will be made and that I will be liable for any expenses incurred by myself or by Kanakuk related to such dismissal (i.e. transportation, lodging, etc.).
- I understand and confirm that my child's contact information provided in this registration may be used by Kanakuk throughout the year for purposes related to the ongoing ministry efforts of Kanakuk.

Because the Kanakuk Program is conducted primarily in the State of Missouri and in order to provide certainty in the law to be applied to the construction of this instrument, this instrument shall be governed, construed, and enforced in accordance with the laws of the State of Missouri. All actions shall be brought and maintained in the courts located in Taney County, Missouri, and I hereby waive all objections to jurisdiction and venue therein.

THIS IS A RELEASE OF LIABILITY, WAIVER, INDEMNIFICATION, AND CONSENT. I HAVE READ THIS RELEASE OF LIABILITY, WAIVER, INDEMNIFICATION, AND CONSENT. I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS AND MY CHILD'S RIGHTS BY SIGNING IT. I AM SIGNING THIS RELEASE OF LIABILITY, WAIVER, INDEMNIFICATION, AND CONSENT VOLUNTARILY.
