  - Reflection of decreased giving in the first quarter

    - Decreased attendance on bad weather days
    - Trend towards annual instead of weekly giving

- o Matthew 22:34-40
- Why are we to love our neighbor?
  - It is a commandment and is inextricably connected to loving God
  - We exist to glorify God and loving our neighbors also glorifies God
  - Puts us in the right relationship with God

- o Barriers
  - Sacrificial and can be messy
  - Inconvenient
  - Focused on personal plans and don't notice others
  - Judgmental
- o Next Steps
  - See your neighbor and have empathy for his/her condition
  - Pray for your neighbor
  - Serve your neighbor
  - Share Jesus with your neighbor
- Walk in Bags
